Sankie Mthemb-Mahanyele grew up in Soweto, Johannesburg. After her Bachelor of Arts of the University of Limpopo, she earned the Post Graduate Diplomas in Economic Principles and in Financial Economics of the University of London, as well as the MSc Public Policy and Management.

1977 she started her career with ANC as a radio journalist, later editor of a women's journal, administrative secretary, chief representative of the ANC mission in Germany, second deputy head of Department of Information and Publicity and in 1993 appointed member of the National Executive Committee of the ANC. From 1995 until 2002 she was national minister for housing; from 2001 until 2003 she held chair of the First World Urban Forum in Kenya. After her station as deputy secretary general of the ANC at the headquarter in Johannesburg, she became member of the Ministerial Committee on Transformation and Social Cohesion and the Elimination of Discrimination in Public Higher Education Institutions.

For one year now, Sankie Mthemb-Mahanyele is Ambassador of South Africa to Switzerland.
